STIPULATED FINDINGS OF FACT AND AGREED ORDER

This Stipulated Findings of Fact and Agreed Order is made and entered into this 29th day of June, 2022, between Clyde Heller, Local Liquor Control Commissioner for the City of Waterloo, Illinois ("Local Liquor Control Commissioner"), and RRR Bar, LLC d/b/a Uncle John's RRR Bar ("Licensee") (together, the "Parties").

WHEREAS, Licensee is licensed to sell alcoholic liquor at 141 South Main Street, Waterloo, Illinois (the "Licensed Premises"), pursuant to Class A Liquor License No. 20, effective July 1, 2021 and expiring on June 30, 2022;

WHEREAS, on various dates between September 12, 2021 and May 23, 2022, Licensee's members, managers, agents, and/or employees were issued various citations and notices relevant to alleged violations of the Liquor Control Act of 1934, 235 ILCS 5/1-1 et seq., and the City of Waterloo, Illinois' Code of Ordinances;

WHEREAS, on June 24, 2022, the Local Liquor Control Commissioner issued a Notice of Hearing and Examination Under Oath to Licensee ("Notice"), a copy of which is attached hereto, marked as Exhibit A, and incorporated herein by reference;

WHEREAS, a hearing on the aforementioned Notice was set to be held on June 30, 2022 at 2:00 p.m. at the Waterloo City Hall to examine Licensee and, further, to determine whether discipline should be imposed upon Licensee for the violations alleged therein;

WHEREAS, the Parties wish to enter into this Stipulated Findings of Fact and Agreed Order to resolve all claims raised in the Notice:

NOW THEREFORE, AND IN CONSIDERATION OF THE PREMISES, the Parties hereby stipulate and agree to the following:

- That Licensee committed the violations alleged in enumerated paragraphs 1, 2, 4,
 and 7 of the Notice attached hereto as Exhibit A.
- 2. That, by agreement, the Local Liquor Control Commissioner is withdrawing the allegations made in enumerated paragraphs 3 and 5 of the Notice.
- 3. That the Local Liquor Control Commissioner will no longer require an examination under oath pursuant to the Notice.
- 4. That the Local Liquor Control Commissioner and Licensee agree to disposition of the aforementioned violations on the terms set forth below:
 - A. That Licensee's pending application for a Class A liquor license for the term commencing July 1, 2022 and ending June 30, 2023 shall be granted.
 - B. That Licensee's liquor license with the City of Waterloo shall be suspended for a period of ten (10) days beginning 12:01 a.m. on July 1, 2022 and ending at 11:59 p.m. on July 10, 2022.
 - C. That Licensee, its members, managers, agents, and employees shall, while acting in said capacities on or about the Licensed Premises, henceforth refrain from using demeaning, mocking, or insulting language, or exhibiting other similar behavior toward the City of Waterloo, Illinois, its agents, and the public generally.

- That Licensee will ensure that its managers, agents, and employees refrain
 from becoming intoxicated while acting in said capacities on the Licensed
 Premises;
- E. That Licensee shall henceforth comply with all federal, state and local laws, regulations, and ordinances regarding the sale of liquor or otherwise;
- F. That Licensee shall disable the front exterior speakers, refrain from installing any other speakers not currently present on the exterior of the Licensed Premises, and remain in compliance with local ordinances with regard to the rear exterior patio speakers presently in place on the Licensed Premises;
- G. That in the event future issues arise by and between the Local Liquor Control Commissioner, the City of Waterloo, and/or the Licensee, that George Obernagel, III, as one of Licensee's members/managers, shall communicate with the City of Waterloo and/or the Local Liquor Control Commissioner, and otherwise actively participate in all efforts to resolve any concerns or disputes arising from activities upon the Licensed Premises; and
- H. That should future discipline be warranted, the violations stipulated to herein and the resultant suspension set forth above may be considered by the Local Liquor Control Commissioner to the same extent as if they had resulted from a full hearing upon the merits.
